

CITY NATIONAL ROCHDALE FUNDS

SUMMARY PROXY VOTING POLICY

The Board of Trustees has adopted a Proxy Voting Policy with respect to voting proxies relating to portfolio securities held by the City National Rochdale Funds¹(the“Policy”), pursuant to which the Board has delegated the responsibility for voting such proxies to City National Rochdale, LLC (“CNR, LLC”) as a part of CNR, LLC’s general management of the City National Rochdale Funds (each, a “Fund”), subject to the Board's continuing oversight. CNR, LLC, in accordance with the Policy, has further delegated the responsibility for voting proxies to the following sub-advisers (together, the “Sub-Advisers”):

A conflict of interest may be deemed to occur when CNR, LLC or the Sub---Advisers or one of their affiliated persons has a financial interest in a matter presented by a proxy to be voted on behalf of a Fund, which may compromise CNR, LLC’s or the Sub---Adviser’s independence of judgment and action in judging the proxy. If such a conflict occurs, CNR, LLC or the Sub---Adviser is required to submit a report to the Board of Trustees indicating the nature of the conflict of interest and how it was resolved.

The "City National Rochdale Funds" include the Dividend & Income, U.S. Core Equity, and Emerging Markets Funds (collectively, “Equity Funds”); Government Bond, Corporate Bond, California Tax Exempt Bond, High Yield Bond, Intermediate Fixed Income, Fixed Income Opportunities, Municipal High Income Funds (collectively, "Bond Funds") and the Government Money Market Fund.
